

Frequently Asked Questions (F.A.Q)

(Please refer Advertisement Dtd.10.06.2021 for recruitment of VSJE(Electrical / Civil)

1. Am I required to send the signed copy of application by post?
No. The print out of the application form should be retained with the candidate. It will be required to be produced whenever asked.
2. Are original documents necessary to bring at examination centers?
No, it will be informed whenever required.
3. What will be the duration of online examination?
The duration of the online examination will be 1(One) hour per session / batch.
4. I do not have my result on hand. I have printout of internet results, what should I do?
Internet printouts will do but must be self-attested and original must match with that.
5. I don't have my degree certificate / provisional certificate. What to do?
Please bring a certificate from college/university confirming the successful completion of degree course with the actual percentage of last two semester Marks.
6. I don't have any Identity proof as mentioned in call letter.
One of the identity proofs as mentioned in the call letter is must.
7. I am having 54.99% aggregate marks in my last two semesters. Am I eligible?
No, not eligible. Minimum 55% aggregate marks in 7th & 8th semesters in complete round figures are required.
8. What does SLC means?
School Leaving Certificate.
9. I have degree of BE (Electronics & Communication). Can I apply?
No. Only the candidates having prescribed degree course mentioned in the advertisement are eligible to apply.
10. What does SGPA / SPI means?
Semester Grade Point Average / Semester Performance Index.

11. What is the full form A.T.K.T.? Are ATKT and Backlog are same?
Allowed To Keep Term. Yes, ATKT & Backlog are same. The candidate should have passed 7th & 8th Semesters in first trial without any ATKT / Backlog.
12. I have ATKT / Backlog in 1st to 6th Semesters. But I do not have ATKT / Backlog in 7th or 8th Semester. Can I apply?
Yes, the candidates should not have ATKT / Backlog in 7th or 8th Semester only.
13. I have ATKT / Backlog only in 7th or 8th Semester. Can I apply?
No, the candidates should not have ATKT / Backlog in any of the last two semesters. Both 7th and 8th Semesters should be cleared without any ATKT / Backlog.
14. When will be online exam conducted?
You will have to keep in touch with our website.
15. How to fill-in the Online Registration Form when there is no semester system but system like year wise marking?
The course should be of Four full years. If candidate has completed Diploma and joined Degree course, in such case, Diploma + 6 Semesters or Diploma + 3 years course duration is essential.
16. What is the syllabus for the exam?
Syllabus is mentioned in the advertisement itself.
17. Can the candidates belonging to out of Gujarat State apply?
Yes. They can apply but State Domicile Policy of Gujarat will be implemented.
18. Can the candidates pursuing 8th semester apply?
Only those candidates who have passed Final Semester of BE Degree as on the last date of submission of online application are eligible to apply.
19. I have obtained degree through Distance Learning Mode / Part Time. Am I eligible?
No. The degree must be Full Time Regular Course only.
20. Is Domicile Certificate necessary?
Domicile Certificate of Gujarat is must for the candidates who wish to take benefit of Gujarat State Domicile Policy.
21. I am native of Gujarat. Is it necessary for me to produce Domicile Certificate?

Yes. Domicile Certificate is must also for those who are native of Gujarat and wish to take the benefit of Gujarat Domicile Policy.

22. Is knowledge of Gujarati essential? I have not passed any Gujarati Language examination? Can I apply?

Knowledge of Gujarati is essential. However, if candidate does not possess any certificate, he has to clear test / exam prescribed by the Company within specified time limit after appointment, if appointed.

23. I am having higher qualification than B.E. like M.E./M.Tech etc. Can I apply? Will I get any benefit of higher qualification?

Candidates having higher educational qualification like M.E./M.Tech can apply. However, the recruitment is purely based on the Bachelor Degree qualification and there is no any additional benefit of higher qualification for the purpose of recruitment.

24. I have no post qualification experience. Can I apply?

No experience is required for the post of VSJE(Electrical / Civil). Fresh engineering graduates having prescribed qualification and meeting with all criteria can apply.

25. Is there any personal interview for selection after online examination?

There will be no personal interview for selection.

26. I am regular departmental employee of GETCO. Can I apply? What will be the age limit?

Yes. Regular departmental employees of GETCO can also apply. The upper age limit will be upto 60 years in case of departmental employees.

27. I have domicile certificate of other than Gujarat State. Can I apply?

The candidate can apply. But, the state domicile policy of Gujarat State will apply. Hence, the candidate should have domicile certificate of Gujarat State, if he/she wants to take benefit of Gujarat State Domicile Policy.
